I, Timothy P. Fox, declare as follows:

- 1. I am a member in good standing of the State Bars of California and Colorado, and Co-Executive Director of the Civil Rights Education and Enforcement Center ("CREEC") in Denver, Colorado. I am an attorney of record for the Plaintiffs in this action. I am familiar with the facts stated below based on my own personal knowledge, and if called upon could and would testify competently about them.
- 2. The hours my co-counsel and I have spent on this case to date were reasonably expended in obtaining an outstanding result for the Class. My co-counsel and I spent time: (1) working closely with Named Plaintiff Lashbrook; (2) analyzing information provided by the City, including the City's curb ramp design standards, policies and procedures, curb ramp database, and request for proposal and scope of services related to the curb ramp survey; (3) researching and drafting correspondence addressing the City's statute of limitations defense; (4) leading and strategizing positions for the negotiations with the City; (5) negotiating the Interim Agreement and Consent Decree; (6) drafting and revising correspondence, pleadings, and settlement documents; (7) communicating with representatives of the City of San Jose; and (8) effectuating the Consent Decree's preliminary approval and notice to the class.
- 3. All attorneys and legal staff at CREEC are instructed to maintain contemporaneous time records reflecting the time spent on this and other matters. This includes contemporaneous recording of the date and amount of time spent on a task to one-tenth of an hour; a description of the work that was performed during the indicated time period; and identification of the case to which the time should be charged. All attorneys and legal staff at CREEC have kept contemporaneous records documenting in detail all time spent on this matter, including recording of the date and amount of time spent on a task to one-tenth of an hour, and a description of the work that was performed during the indicated time period. Attached hereto as Exhibit A are true and correct records reflecting CREEC's time spent on this case.
- 4. We made every effort not to duplicate billing, and to proceed in an efficient manner, assigning the appropriate attorney or staff member to distinct and necessary tasks based on their

particular skills and experience.

- 5. I have reviewed CREEC's billing records on an entry-by-entry basis to exercise billing judgment and excise inefficient or duplicative work, clerical entries, and other billing entries that are otherwise inadequate or non-compensable. This reduced the overall lodestar by 1.5%.
- 6. The following table accurately sets forth the timekeepers at CREEC who worked on this matter; their graduation dates; their hourly rates that we are seeking; and the number of hours that they worked, after the exercise of billing judgment:

- 7. CREEC's 2020 rates represent a modest increase from 2019. For example, my hourly rate increased less than 2%, from \$875 to \$890, from 2019 to 2020. The rate for CREEC's second top timekeeper, Sarah Morris, increased 4%, from \$500 to \$520, from 2019 to 2020. Using CREEC's 2019 rates, CREEC's lodestar is \$112,809.50.
- 8. Class Counsel's current out-of-pocket expenses are approximately \$803.47 for travel expenses. Attached hereto as Exhibit B are true and correct records reflecting the expenses we have incurred in this litigation, as well as an itemized summary of these expenses.
- 9. CREEC's costs and out-of-pocket expenses are minimal given that the parties engaged in structured negotiations.
- 10. All expenses and costs incurred were necessary for the negotiation and litigation of Plaintiff's claims, and are appropriate given the scope and complexity of this matter.
