WHEREAS, on December 20, 2016, the Court entered an order (the "Final Approval Order") granting final approval of the settlement of this action, the terms of which are embodied in the Joint Stipulation and Class and PAGA Action Settlement (the "Settlement"), finding that the settlement is fair, adequate, and reasonable:

Without affecting the finality of this Judgment in any way, the Court reserves exclusive and continuing jurisdiction over this action, the Class Representatives, the Settlement Class, and the Defendant (as those terms are defined in the Agreement) for the purposes of supervising the implementation, enforcement, construction and interpretation of the Settlement, the Preliminary Approval Order, the Final Approval Order, and this final Judgment and the distribution of Settlement payments and tax forms.

IT IS SO ORDERED AND ADJUDGED. LET JUDGMENT BE FORTHWITH ENTERED ACCORDINGLY.
