On September 30, 2016, Plaintiffs filed an unopposed *Ex Parte* Application Requesting Modification to the Preliminary Approval Order's Implementation Schedule, Approval of the Revised Class Notice, and a Continuance of the Final Approval Hearing. Having considered the papers and arguments of counsel, including the Joint Stipulation in Support of Plaintiffs' *Ex Parte* Application, and finding good cause, the Court hereby GRANTS Plaintiffs' *Ex Parte* Application to Modify the Preliminary Approval Order's Implementation Schedule, Approve the Revised Class Notice, and Continue the Final Approval Hearing

IT IS ORDERED that the Final Approval Hearing original scheduled for October 28, 2016 shall be continued until December 20, 2016 at 9:30am, in Department 302 of this Court.

IT IS ORDERED that the Revised Class Notice (attached as Exhibit A to the Parties' Joint Stipulation) is approved, and the Parties can make non-substantive changes necessary to finalize the Class Notice consistent with this Order and the Settlement Agreement.

IT IS ORDERED that the implementation schedule is modified to the following:

Within eight (8) calendar days after the Order Modifying Implementation Schedule and Continuing the Final Approval Hearing.	Settlement Administrator to mail Class Notice.
Within forty-five (45) calendar days after mailing of the Class Notice.	Deadline for challenges to calculation of settlement award.
Sixty (60) calendar days after mailing of the Class Notice.	Deadline for Objections and/or Opt out
Within ten (10) calendar days of the Final Approval Hearing.	Class Counsel to file their motion for final approval and notify the LWDA of the final approval hearing details.
	Settlement Administrator to file and serve its certification of completed duties and results of Class Notice processes.
December 20, 2016	Final Approval Hearing.
Within fifteen (15) calendar days after the Settlement Effective Date but no earlier than January 1, 2017.	Settlement Administrator shall issue settlement checks from Defendant's First Payment to the Settlement Fund to Participating Settlement Class Members, Class Representatives, Class Counsel, the Settlement Administrator, and the California Labor & Workforce Development Agency.

Within twelve (12) months of Final Approval.	Defendant to transfer the Second Payment to the Settlement Fund to the Settlement Administrator.
Within fifteen (15) calendar days after Defendant's Second Payment to the Settlement Fund is received by the Settlement Administrator.	Settlement Administrator shall issue settlement checks from Defendant's Second Payment to the Settlement Fund to Participating Settlement Class Members, Class Representatives, Class Counsel, the Settlement Administrator, and the California Labor & Workforce Development Agency.

IT IS ORDERED that to the extent this Order conflicts with any term of the Settlement Agreement, this Order will control and shall modify the Settlement Agreement accordingly.

IT IS ORDERED that Plaintiffs shall provide timely notice of the Final Approval Hearing date to the California Labor & Workforce Development Agency.
